**Sugar Plum Faire  
Vendor Participation Agreement**

This vendor participation agreement is made by and between Bright Water Waldorf Society dba Bright Water Waldorf School ("BWWS") and the undersigned vendor ("Vendor"). BWWS agrees to provide Vendor space and a table for the purpose of selling goods at BWWS's Sugar Plum Faire to be held on Saturday, December 8<sup>th</sup>, 2018 from 11AM to 3 PM. Vendor agrees to pay BWWS the sum of fifty dollars (\$50) for a 6 foot table spot or twenty five dollars (\$25) for a 3 foot table spot. The parties further agree as follows:

**Sales Tax**

Vendors will pay all taxes to the appropriate taxing authorities including but not limited to sales and use taxes which accrue from the Vendor's sales.

**Set-up / Take Down Time**

Vendor may set up between 9.45-11 AM and will take down and vacate between 3-4 pm on Saturday, December 8<sup>th</sup>, 2018. Vendor shall unload and load his/her own vehicle and transport all his/her own property. Vendor shall provide his/her own table cloth, display materials, mirrors, etc. BWWS will provide vendor with a table and chair. Electricity for displays is not available. WIFI is available should you need it.

**Parking**

Vendors may park in the playground area in the back of the school. There is also street parking in the neighborhood with posted restrictions.

**BWWS Not Responsible for Lost or Stolen Property**

BWWS is not responsible for Vendor's lost or stolen property. Vendor is responsible for safeguarding Vendor's property and insuring against any loss.

**Professional Conduct**

Vendor shall act professionally towards Faire attendees and treat BWWS facilities and property with care.

**Force Majeure**

In the event that severe weather, natural disaster or unforeseen events cause BWWS to cancel Sugar Plum Faire both parties are excused from performance. BWWS shall refund Vendor's payment. BWWS shall not be liable for any other damages that may result to Vendor as a result of the faire's cancellation.

I acknowledge that I have read, understand and agree to be bound by the terms of this Agreement and hold BWWS harmless, waiving and releasing any and all right and claim for damages against BWWS in connection with this event for any and all damages, losses, thefts or injuries which are suffered while taking part in any activities linked to this event.
